

## Terms and Conditions

### Guylian Belgian Chocolate Café Spring Competition 2018

- 8 Subject to relevant state authority approval, the Promoter reserves the right, in its absolute discretion, at any time before the awarding of the prize to cancel the Competition or to vary or cancel the award of the prize including, without limitation, circumstances where in the Promoter's opinion (which it shall form in its absolute discretion): (a) a prize winner does not satisfy the Competition entry requirements; or (b) the Promoter cannot conduct the Competition or award the prize for any reason beyond its control.
